FINANCE & RESOURCES COMMITTEE MEETING - 6th NOVEMBER 2018

FR09/18 DECLARATIONS OF INTEREST

Councillor Roz Stirman declared an interest as a Member of BCBC.

FR10/18 TO APPOINT A CHAIR

Following Councillor J Davies' resignation from the Council, Councillor Rees Jones was elected as the Bettws ward representative on the Finance Committee. Councillor Davies' resignation left the Committee without a Chair and it was proposed that Councillor H Griffiths be elected Chair, this was seconded and Councillor Griffiths was successfully elected.

FR11/18 TO READ, CONSIDER AND APPROVE THE MINUTES OF THE FINANCE & RESOURCES COMMITTEE MEETING HELD ON 10TH JULY 2018

Resolved: The Minutes of the meeting held on 10th July 2018 were accepted as a true and accurate record; with this, the Chairman duly signed the Minute Book.

FR012/18 MATTERS ARISING FROM THE JULY 2018 MEETING

FR13/18 TO REVIEW THE COUNCIL'S BUDGET AND IDENTIFY ANY POTENTIAL RISKS

The Clerk presented the up-to-date budget monitoring figures and these were discussed. The balance carried forward to November 2018 was £89,743.44

FR014/18 TO DISCUSS THE COMMUNITY COUNCIL'S PRECEPT REQUEST FOR 2019/2020

Items approved at Full Council put forward by the Strategy Committee were accepted and included in the draft precept. In addition other suggestions were made and discussed and members proposed a draft precept budget to be put before Full Council at its 3rd December Precept Meeting. The Clerk tabled a document showing the previous year's precept breakdown and it was noted that the Band D figure was not yet available.

Resolved: The Clerk was asked to draft a precept budget based on the discussion and suggestions made to present to Full Council.

FR015/18 TO CONSIDER THE 2019/20 ALLOCATION UNDER THE TOWN AND COMMUNITY COUNCIL FUND

Suggestions were made and discussed.

Resolved: It was agreed to recommend to Full Council to apply for match funding to upgrade the play area at Waun Bant in Pontycymer to include flower displays, new bins, painting of the fence and gates, cleaning, inclusion of additional equipment i.e provision for disabled equipment.
